LSF program offerings audited for TVET star rating

TVET experts from Region XI headed by Compostela Provincial Director, Ms. Arlyn S. Bandong, audited the 16 program offerings of Lupon School of Fisheries (LSF) on September 7, 2016 to categorize the programs into good, better, or best with corresponding stars.
