Talavera talked about RA 10931 "Universal Access to Quality Tertiary Education Act of 2017 (UAQTEA)" TVET Primer during the Administrators Conference on April 17— 20, 2018 held at the Apo View Hotel Davao City: How to provide adequate funding and such other mechanisms to increase the participation rate among all socioeconomic classes in tertiary education; Provide all Filipinos with equal opportunity to quality tertiary education in both private and public education institutions; Give priority to learners who are technically able and who came from poor fami

lies; Ensure the optimized utilization of government resources in education; Provide adequate guidance and incentives in supporting young Filipinos with their career choices towards the proper development and utilization of human resources; and Recognize the complementary roles of public and private TVIs in the tertiary education system.

The main agency in charge of managing the implementation of R.A. 10931 is the Unified Student Financial Assistance for Tertiary Education (UniFAST) Board.

Different booths were setup where enrollees can inquire and enroll on TESDA program offerings, be oriented on the requirements for their preferred qualifications, and be enlisted when qualified in the available TVET programs for the school year 2018-2019. DOLE provided list of employers, companies, recruitment agencies and organizations, shared available guidelines, mechanics and other relevant information and provided assistance to the applicants. Partner industries provided list of available jobs that can be posted by TESDA for reference of the job seekers, conducted on the spot interviews if necessary and

oriented the job seekers on the requirements for the job openings.

Many enrollees and applicants arrived since enrollment was opened to all Filipinos 15 years old and above who are interested to take TVET programs offered by the institution such Bartending NC II, Bread and Pastry NCII, Cookery NC II, Driving NCII, RAC NCII, CSS II, EPASS NCII, Automotive NCI and NCII and many more. TVET graduates looking for work/employment also came for the jobs bridging.

The FREE TVET to be implemented in STVIs shall cover the following: tuition and other training-related fees; consumables; cost of utilities; cost of facilities, equipment and tools maintenance; honorarium of trainers; living allowance (transportation, living allowance and board & lodging); miscellaneous fees; National Competency Assessment fee; instructional materials allowance; and starter toolkit. Students can avail the UAQTEA if they pass the entrance exam and interview prepared by respective STVIs. On the other hand, TWSP slots shall be implemented by Private TVIs.

In April 18-19, 2018, Every Operating Unit (OU) and Provincial Training Center (PTC) were encouraged to apply for East Asia Summit TVET (EASTVET), STAR Rating System of TVET Programs and Asia Pacific Accreditation and Certification Commission (APACC) accreditation.

Executive Director Elmer K. Talavera presented the APACC score and results of TTI's with the GOLD Level Accreditation including the strength as well as the weak points which need action to fill in the gaps in achieving the 100% points required by APACC.

Completion of the conference, DDG Rosanna A. Urdaneta supported the advocacy of free education for all. She firmly encouraged each administrator to spread the good news. In the near future there will be no Filipinos who will experience poverty because they will be equipped with knowledge and skills which are
